AT A POLICE STATION IN BANFIELD, JUST OUTSIDE THE FEDERAL DISTRICT IN BUENOS AIRES PROVINCE. A POLICE COMISARIO WAS PRESENT THROUGHOUT THE MEETING. TIMERMAN NOW APPARENTLY IS BEING HELD AT BANFIELD POLICE STATION ALONG WITH OTHER "IMPORTANT" ARGENTINES INCLUDING VICTORIO CALABRO, EX-GOVERNOR OF BUENOS AIRES PROVINCE.

3. ACCORDING TO THE SON, TIMERMAN WAS IN GOOD HEALTH AND HAD NOT BEEN INTERROGATED OR TORTURED RECENTLY. HECTOR SPECULATED THAT HIS FATHER MAY SOON BE RETURNED TO MORENO JAIL IN BUENOS AIRES PROPER.
